#### Act 55 of 2022

- Section 1525. Agreements with Institutions of Higher Education (IHE)
  - School districts, charter schools, cyber charter schools, regional charter schools, and CTCs must have at least one dual enrollment agreement with a Pennsylvania postsecondary institution
  - Schools may enter into additional agreements with other IHEs approved to operate in PA in order to allow students to attend the IHEs while the students are enrolled in school
  - Credits earned by secondary school students shall be the same credits
    offered to a postsecondary school student enrolled at an IHE and also count
    towards high school graduation
  - Courses may be offered in-person, online or a combination of both
  - No later than July 31, 2023, and annually thereafter, the school shall provide to PDE the number and form of agreements the school entity has entered into under this section and the number of students participating in the agreements, including total credits earned



## PDE Dual Enrollment Grant Program

### **Design Elements**

 Eligible applicant: School districts, charter schools, cyber charter schools, regional charter schools, and CTCs

 Type of Grant: Competitive grants that begin to offer or expand dual enrollment course availability to students





## PDE Dual Enrollment Grant Program

#### **Design Elements**

- Preference given to proposals:
  - From schools where at least 25% of students come from low-income families
  - That include agreements with multiple IHEs or regional consortia
  - IHEs with National Alliance for Concurrent Enrollment Partnerships (NACEP) accreditation
  - Dual enrollment courses that utilize open educational resources (OER) and are either low-cost or no cost to students
  - Extent of IHE tuition discounting
  - Lead to a postsecondary certificate, associate's degree, or bachelor's degree in education (especially in educator shortage areas), health, or other highneed area



## PDE Dual Enrollment Grant Program

#### **Design Elements**

- Modality: Asynchronous or Synchronous (in-person, online, or hybrid)
- Instruction: IHE-approved secondary teachers or IHE instructors/faculty
- Use of funds: instructor salaries; books/materials; wraparound support services for students; financial assistance for secondary teachers to take additional graduate level courses to meet requirements to be approved as IHE instructors/faculty; provision of services, support, and coordination of resources for established partnerships
